- Vendor agrees to be open and staffed during the duration of the expo (from 10AM 3PM) and to engage with tees.
- Vendor agrees that display will not intrude on aisles or adjacent exhibitors.
- Vendor fees are non-refundable and non-transferrable. No refunds will be made to vendors who fail to occupy space.
- Vendor is responsible for the cost of move in or out and is liable for any damage caused to the exhibit space in connection with the exhibit.
- Vendor assumes responsibility for any loss, theft or destruction of goods or for personal injuries to him/herself, his/her employees, agents, representatives, and will hold harmless the City of DeSoto, DeSoto Public Library and the DeSoto Public Library Best Southwest Everything Teen Expo from any and all liability in connection with any and all of the above.
